# **EMERGENCY SQUAD**

#### MOTION#310/16-17

A motion was made by Trustee Moore seconded by Trustee Strauss to authorize the purchase of 30 pagers as the last phase of the radio upgrades from low band to VHF from Tri County Communications in the amount of \$8604.00. After rebate this cost is \$286.80 a piece, two other companies were quoted at \$399 and \$391 a pager. The motion carried unanimously.

Assistant Fire Chief Zacharias informed the board that they had assisted the school in its second lockdown drill. Zacharias also asked that residents keep the fire hydrants cleaned when shoveling snow. Further he stated that the stair chair will be purchased with money from Senator Akshar and a donation from the closet with only \$263.00 from the budget.

# STREETS

Supervisor Davie informed the board that the guiderails will cost about \$23,000 for 1,000 feet. Davie stated once started it needs to be completed - the rails cannot be installed piecemeal. Davie stated that the DPW will be removing all the trees in Front St. and will need permission to take them down from the store owner. Davie also informed the board that the Village can reject the results of the auction for the surplus equipment. Further, Davie gave the board new and used roller prices for their consideration.

Davie then asked the board if they wanted him to wait until 7 a.m. to plow cinder or salt if needed or to come in early. Trustee Moore said the taxpayers going to work will appreciate the roads being cleaned up - come in early.

#### MOTION#311/16-17

A motion was made by Trustee O'Connell seconded by Trustee Moore to authorize the

Mayor's signature on the current DOT Agreement as submitted. The motion carried unanimously.

Davie informed the board he was down two men - Jay and John, so if there is snow storm he wanted the board to realize he was short two men.

# **GUESTS**

John O'Connor asked the Mayor about the empty chair in the trustee spot. She receives the same pay as the rest and it's all tax dollars - it bothers me that she does not attend. The Mayor replied that she is positively contributing to the meetings, just because she isn't sitting in her chair does not mean she is not contributing to the whole and I can't believe you are questioning the position. Mr. O'Connor said that he is questioning the vacancy of the seat almost each meeting. The Mayor said Ms. Freyer was put on bed rest by her Doctor. Mayor Rynearson stated it was a temporary position and he is not her keeper - he cannot make her attend. Rynearson stated your three minutes are up, thank you for your question.
